WHEREAS, the State of California provides funds for local bikeway projects under the Transportation Development Act of 1971; and

WHEREAS, the San Diego Association of Governments (SANDAG) is the local agency which administers Local Transportation Funds (LTF); and

WHEREAS, the City Council by Resolution No. R-258627, dated June 13, 1983, authorized the City Manager to submit claims to SANDAG and accept LTF funds for various bikeway projects; and

WHEREAS, on June 24, 1983, SANDAG approved an allocation of \$295,710 in LTF to the City for various bikeway and pedestrian projects; and

WHEREAS, the City's LTF claim identified \$64,400 specifically for the development of a bikeway for Gilman Drive; and

WHEREAS, the intent of that specific project was that the City would apply for funds but the bikeway would be designed and constructed by the University of California at San Diego (UCSD); and

WHEREAS, this bikeway project represents the completion of the planned bicycle network as shown in the University Community Plan and also is consistent with the City's Master Bikeway Map; and WHEREAS, included therein is the requirement for an agreement with UCSD to accomplish this project and to provide for the transfer of LTF monies for that purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the REGENTS OF THE UNIVERSITY OF CALIFORNIA, to construct a bikeway on Gilman Drive from Villa La Jolla Drive to the entrance of UCSD, as more specifically set forth and in accordance with time limits contained in the LTF package prepared by the City Manager, and in accordance with the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$64,400 in LTF funds to UCSD to be used solely and exclusively for the above purpose.
