That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$300,000 in the settlement of each and every claim against The City of San Diego, its agents and employees [Superior Court Case No. 476730, Carolyn Oldner v. City of San Diego, et al.] resulting from the personal injuries of Carolyn Oldner.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the total amount of \$300,000 made payable to Carolyn Oldner and her attorney of record, Robert Baron, in full settlement of the lawsuit and of all claims.
