APPROVING MAP OF BLACK MOUNTAIN GLEN

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Robert G. Schoettmer, licensed land surveyor, entitled "BLACK MOUNTAIN GLEN, being a subdivision of Parcel 2 of Parcel Map No. 12443, in the City of San Diego, County of San Diego, State of California, according to Map thereof filed in the office of the County Recorder of San Diego County on November 22, 1982, together with Road survey No. 3 as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: El Vestido Street, Milbury Road, Amby Court, Vintage Drive, Newmont Drive, Felson Road, Emden Road, Hesby Court, Meadowrun Street, Elford Court, Wescott Court, Ibex Court, Danby Court, Cadley Court, Maler Road, Bedel Court, Ringate Court, Penford Court and portions of Carmel Valley Road and Black Mountain Road, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Carmel Valley Road, adjacent and contiguous to Lots 168 through 187, inclusive, 192, 193, 197, 198 and 211; in and to Black Mountain Road, adjacent and contiguous to Lots 18, 19, 26, 27, 136, 137, 148, 149, 155, 213 and 214, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over all of Lots 211, 212 and 214, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal

corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Black Mountain Road and Ossuna Canon Road approved by Council Resolution R-257883 on January 31, 1983 concurrently with the filing of the map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
