APPROVING MAP OF VALLEY BREEZE

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by William Gregory Clarke, entitled "VALLEY BREEZE, being a subdivision of portions of Lots 12 and 13 of Tibbetts Tract, in the City of San Diego, County of San Diego, State of California, according to amended map thereof, Licensed Surveyor's Map No. 24, filed in the office of the County Recorder of San Diego County, November 25. 1892," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities,

all as granted and shown on this map within this subdivision,  
are accepted on behalf of The City of San Diego, a municipal  
corporation, as above stated.

San Diego, California.
