WHEREAS, SAN DIEGO GAS & ELECTRIC COMPANY, has requested an exchange of electrical easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that quitclaim deed of SAN DIEGO GAS & ELECTRIC COMPANY, executed in favor of The City of San Diego, bearing date of October 4, 1983, conveying to said City certain overhead easement rights in City-owned Southeast Quarter of Section 30, Township 12 South, Range 1 West, S.B.B.M., as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259649-1, is hereby approved.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 259649-2, conveying to SAN DIEGO GAS & ELECTRIC COMPANY an easement for overhead electrical facilities affecting

City-owned Southeast Quarter of the Southeast Quarter of Section 30, Township 12 South, Range 1 West, S.B.B.M., as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
