

BE IT RESOLVED, by the Council of The City of San Diego, that this City Council does hereby accept the proposed interchange construction design as CALTRANS has proposed.



BE IT FURTHER RESOLVED, that the City Council requests that CALTRANS study and work with the affected community on the implementation of a cut and cover concept for the portions of Interstate 15 southerly of the interchange whereby the new freeway would be placed below the level of the adjacent property and cross streets remain at their current grade.
