Florencia V. Santos	Building Inspection	\$ 305	Ms. Santos is an Intermediate Typist. She suggested the revision of the sign permit to include multiple signs at the same address on one form. This is expected to save \$1,013 in the first year in costs for forms, microfilming and labor costs.
John P. Coggins	Police	\$ 155	Mr. Coggins is a Stock Clerk. He suggested that a weekly billing procedure for shipments through the United Parcel Service be initiated. This is expected to save \$520 in the first year in labor costs.
Raymond E. Burns	Fire	\$ 130	Mr. Burns is an Equipment Mechanic. He suggested that water cross over tubes for the fire trucks be purchased from a local muffler shop rather than the manufacturer. This is expected to save \$435 in the first year in costs for material.
