			She suggested that the transmissometer used for monthly ocean sampling be connected directly to the boat batteries to eliminate the charging and maintenance of portable batteries. This is expected to save \$997 in the first year in labor costs and is also a safety improvement.
Raymond E. Burns	Fire	\$ 75	Mr. Burns is an Equipment Mechanic. He suggested the revision of the exhaust systems on the Seagrave fire engines to a vertical system. This is expected to save \$258 in the first year in labor and material costs.
Leo Harris	Water Utilities	\$ 25	Mr. Harris is an Equipment Mechanic. He suggested the purchase of a different glove for the crews on the flusher trucks. Although savings were difficult to identify, this was considered to be a significant operational improvement.
