
WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,

BREN COMPANY, a California corporation, all the City's right, title and interest in the sewer easement, as more particularly described in said quitclaim deed.

That the City Clerk is hereby directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
