That the acceptance by the City Manager of those street and drainage easement deeds of DEL MAR UNION SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, bearing date of July 29, 1983, and ARTHUR J. VAN PRAET and PATRICIA M. VAN PRAET, bearing date of April 26, 1983, executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 259703-1 and RR- 259703-2, granting to said City easements for street and drainage purposes in a portion of the Southeast Quarter of the Northwest Quarter of Section 24, Township 14 South, Range 4 West, San Bernardino Base and Meridian, and in a portion of Lot 17, Del Mar Hills, Unit No. 9, Map No. 6322, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named MIRA MONTANA DRIVE.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
