WHEREAS, an access easement was acquired for the development of the subdivision known as Sandy Olson Subdivision Unit No. 1; and

WHEREAS, the aforementioned access easement will no longer serve the purpose for which it was acquired; and

WHEREAS, the City has no present or prospective public use for a portion of the access easement, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the access easement was acquired at no cost and ROBINHOOD HOMES, INC., a California corporation, has paid all City costs in connection with processing the matter of quitclaiming the easement; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259712-1, quitclaiming to ROBINHOOD HOMES, INC., a California corporation, all the City's right, title and interest in the access easement, as more particularly described in said quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City  
be, and he is hereby authorized and directed to cause the deed  
and a certified copy of this resolution, attested by him under  
seal, to be recorded in the office of the County Recorder.
