## RESOLUTION NUMBER R- 259718 Adopted on DEC5 1983

WHEREAS, disposal of hazardous wastes is of vital importance to the health, safety and welfare of the citizens of the City of San Diego, and

WHEREAS, since 1980, there has been no publicly operated hazardous waste landfill in this area, and

WHEREAS, violations by small businesses and households, of federal and state law, regarding the disposal of hazardous wastes continue to occur resulting in seepage of hazardous wastes into sewers, storm drains, municipal landfills, vacant lots and other inappropriate dumping grounds, and

WHEREAS, the Environmental Health Condition (EHC) and the County of San Diego (County) have negotiated a contract implementing a program for the disposal of hazardous wastes generated by small businesses and households (Small Generator Hazardous Waste Disposal Program), and

WHEREAS, the contract will be performed throughout the County, including the City of San Diego, and is contingent upon co-funding in the amount of \$35,000 by the City of San Diego,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that the Small Generator Hazardous Waste Disposal Program (Program) will be of major benefit to the City of San Diego.

BE IT FURTHER RESOLVED, that the expenditure of \$35,000 be and is hereby authorized solely and exclusively for the City of San Diego's contribution to the Program.

BE IT FUTHER RESOLVED, that the contribution by the City of San Diego to the Program is contingent upon the execution of an agreement between the City of San Diego and County, the consideration of which shall be that the terms of the Program contract, including but not limited to, hold harmless clauses and insurance and bonding requirements, be enforced by County for the benefit of the City of San Diego.
