

RESOLUTION NUMBER R- 259735

Adopted on DEC 5 1983

WHEREAS, The City of San Diego has worked cooperatively with the San Diego Association of Governments ("SANDAG") to develop the 1983 Draft Regional Transportation Plan ("RTP"); and

WHEREAS, the RTP is consistent with the Progress Guide and General Plan for The City of San Diego; and

WHEREAS, the City Council Committee on Transportation and Land Use has reviewed the RTP on November 14, 1983, and recommends that the City support it with the following amendments:

(1) That the evaluation of potential local transit funding sources called for in the RTP be expanded to address all transportation needs for which a local source is appropriate, and that evaluation of the local sales tax alternative not be limited to 1/4 of one-percent.

(2) That the RTP call for evaluation of the cost-effectiveness of upgrading the existing AMTRAK service as an alternative to development of the bullet train.

(3) That the RTP call for development of a more aggressive transit marketing program including an employer support program involving subsidy of employee bus passes.

(4) That the RTP call for construction of Route
54 as a freeway in 1995 instead of 2005; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San
Diego, that the City's representative to SANDAG, be and he
is hereby authorized to present the City's position in
support of the RTP with amendments as recommended by the
Transportation and Land Use Committee.
