

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of STAFFORD HANNON, ALICE LEE GREGG INGLEDUE, AND ALICE LEE GREGG INGLEDUE AS TRUSTEE UNDER THE WILL OF J. LEE GREGG, DECEASED; TWIN TRAILS PARTNERSHIP, a general partnership; and TWIN TRAILS PARTNERSHIP, a general partnership, STAFFORD HANNON, ALICE LEE GREGG INGLEDUE, AND ALICE LEE GREGG INGLEDUE, TRUSTEE UNDER THE WILL OF J. LEE GREGG, DECEASED; all executed in favor of The City of San Diego, and all bearing date of September 14, 1983, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 259769 -/ , RR- 259769-2 and RR- 259769-3 , granting to said City easements for public street and drainage purposes in portions of the Northeast Quarter of Section 13, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named CARMEL MOUNTAIN ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
