The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Black Mountain Road, also known as Road Survey 1255 and Old Survey 57, approved by Council Resolution R-259475 on October 24, 1983, concurrently with the filing of the map.
