RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO INITIATING PROCEEDINGS FOR A REORGANIZATION INVOLVING AN ANNEXATION TO THE CITY OF SAN DIEGO AND A DETACHMENT FROM THE SAN DIEGO COUNTY FLOOD CONTROL DISTRICT - ZONE 2.

WHEREAS, pursuant to the District Reorganization Act of 1965, commencing with Section 56000 of the Government Code, the Council of The City of San Diego on July 18, 1983, adopted its resolution of application No. R-258887 to the Local Agency Formation Commission, making a proposal for a reorganization involving the:

1. Annexation of the territory described in the application on file with the Local Agency Formation Commission to the City of San Diego; and

2. Detachment of the territory described in the application on file with the Local Agency Formation Commission from the San Diego County Flood Control District - Zone 2; and

WHEREAS, on November 7, 1983, the Local Agency Formation Commission by Resolution No. R083-12 (attached hereto as Exhibit A), approved the proposed reorganization and authorized the Council of The City of San Diego to initiate and conduct proceedings for the proposed reorganization in compliance with Resolution No. R083-12 and pursuant to Government Code Section 56000 et seq.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby adopts this resolution initiating proceedings for the proposed reorganization consisting of an annexation to the City of San Diego and a detachment from the San Diego County Flood Control District - Zone 2, as provided in Government Code Section 56430, as follows:

A. The name of the areas for which any change of organization is proposed is entitled "Lower Mission Gorge Reorganization." The reorganization consists of the Annexation to the City of San Diego and Detachment from the San Diego County Flood Control District - Zone 2 (as described in Exhibit "A," attached to the Local Agency Formation Commission Resolution No. R083-12). All such areas are located in San Diego County, California.

B. The particular changes of organization proposed for each of the subject areas are the:

(1) Annexation of the territory described in the application on file with the Local Agency Formation Commission to the City of San Diego.

(2) Detachment of the territory described in the application on file with the Local Agency Formation Commission from the San Diego County Flood Control District - Zone 2.

C. Said changes or organization shall be subject to the terms and conditions specified in Resolution No. R083-12 of the Local Agency Formation Commission.

Reference is hereby made to Resolution No. R083-12 of the Local Agency Formation Commission for a full and complete description of said terms and conditions.

D. Preliminary proceedings were commenced when the Council of The City of San Diego on July 18, 1983, adopted its resolution of application R-258887 to the Local Agency Formation Commission making a proposal for this reorganization.

E. The reasons for the proposed reorganization are:

(1) It would eliminate an unincorporated island completely surrounded by territory within The City of San Diego; and

(2) The City can provide an equivalent or better level of services more economically.

F. The Council hereby fixes 10:00 A.M., ~~P.M.~~ January 24, 1984 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for a public hearing to hear all persons interested in, or objecting to the proposed reorganization.


G. Any interested person desiring to make written protest against said reorganization shall do so by written communication filed with the Clerk of the City of San Diego not later than the hour set for hearing. A written protest by landowner shall contain

a description sufficient to identify the land owned by him; a protest by a voter shall contain the residential address of such voter.

H. The Clerk of the City of San Diego is authorized and instructed to publish the notice of hearing according to Sections 56083 - 56086 of the California Government Code.
