RESOLUTION NUMBER R- 259797

WHEREAS, SAN DIEGO GAS & ELECTRIC COMPANY has requested an exchange of electrical easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that quitclaim deed of SAN DIEGO GAS & ELECTRIC COMPANY, executed in favor of The City of San Diego, bearing date of October 6, 1983, quitclaiming to said City certain underground easement rights in City-owned portion of Rancho San Bernardo, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 259797 - /, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 259797 - 2, conveying to SAN DIEGO GAS & ELECTRIC COMPANY, an easement for underground electrical facilities and appurtenances affecting City-owned portion of Rancho San

Bernardo, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
