WHEREAS, The City of San Diego desires to undertake a certain project designated "San Diego Street Youth Program" to be funded in part from funds made available through the Juvenile Justice and Delinquency Prevention Act of 1974, Public Law 93-415, administered by the Office of Criminal Justice Planning; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to submit for and on behalf of said City, a Grant Application to the Office of Criminal Justice Planning, hereafter referred to as OCJP, for funds in the amount of \$74,849, to be made available through the Juvenile Justice and Delinquency Prevention Act of 1974 and administered by OCJP, for the purpose of funding, in part, the operations of the San Diego Street Youth Program during the period of January 1, 1984 to September 30, 1984, under the terms and conditions set forth in said Grant Agreement on file in the office of the City Clerk as Document No. RR-259807

BE IT FURTHER RESOLVED, that upon approval by OCJP of the Grant Application submitted by the City, the City Manager is fully authorized to execute for and on behalf of The City of San Diego, a contractual agreement with OCJP, including any extensions or amendments thereto, for the purpose of performing the services described in said Grant Application.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall be expended solely and exclusively for the purpose of operating, in part, the San Diego Street Youth Program and shall not be used to supplant local juvenile justice expenditures that are controlled by The City of San Diego.
