RESOLUTION NUMBER R- 259813

Adopted on DEC 12 1983

WHEREAS, the City Council adopted Resolution No. 257657 on December 13, 1982 which provided that City representation on the Local Area Formation Commission, (herein called "LAFCO") be included in the 1983 legislative sponsorship program; and

WHEREAS, such proposal was, in fact, included in legislative sponsorship program and forwarded through appropriate channels to Sacramento; and

WHEREAS, Assemblywoman Lucy Killea introduced legislation, AB 1016, which was signed into law by the Governor on August 31, 1983 to accomplish said objective by increasing the membership of LAFCO to include a member, and an alternate, for The City of San Diego; and

WHEREAS, said legislation amended and is now included in California Government Code section 54780.3, with an effective commencement date of January 1, 1984; and


WHEREAS, said section 54780.3 also provides that The City of San Diego member and, in his or her absence, the alternate, shall have full Commission membership and enjoy all the rights and privileges appurtenant thereto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council acknowledges and supports the purpose and effect of AB 1016 (Killea) and expresses the intent of the City to exercise all rights and privileges attendant with membership

on LAFCO as provided for and contained in AB 1016 (Killea) and  
now codified in section 54773, et seq. of the California  
Government Code.
