WHEREAS, in 1982 the San Diego County Disposal Association filed suit against the City contending that the exchange of Water Utilities' 73 percent interest in the North Chollas site for general City land in Beeler Canyon represented inadequate compensation; and

WHEREAS, in order to comply with the judgment and order issued on October 14, 1983, in San Diego County Disposal Assoc. v. The City of San Diego, Superior Court No. 482784, Council Resolution No. 255062, adopted by the City Council on September 22, 1981, should be rescinded; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. 255062, adopted by the City Council on September 22, 1981, is hereby rescinded and the City-owned properties located in the North Collas area and the Beeler Canyon area are hereby returned to their status as such status existed prior to the adoption of said Resolution No. 255062.
