

RESOLUTION NUMBER R- 259834

BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the acceptance by the City Manager of those street, drainage and drainage access easement deeds of HENRY E. RIIS and ESTHER L. RIIS, as Trustees under Declaration of Trust dated March 17, 1981, bearing date of October 29, 1983; RUDOLPH E. RIIS and ELIZABETH A. RIIS, dated October 3, 1983; VILLAGE PROPERTIES, a general partnership, dated October 7, 1983; FRANK ANTON KNECHTEL, aka Frank A. Knechtel, dated October 12, 1983; and BALDWIN BUILDERS, a California corporation, dated October 13, 1983, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 259834-1 , RR- 259834-2 , RR- 259834-3 , RR- 259834-4 , RR- 259834-5 , RR- 259834-6 and RR- 259834-7 , granting to said City easements for public streets, drainage and drainage access in portions of the Southeast Quarter of the Southwest Quarter of Section 19, Township 14 South, Range 3 West, San Bernardino Base and Meridian; in Parcel 2 of Parcel Map 11045 and in portions of Parcels 6, 7, 8 and 9 of Parcel Map No. 12871, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named CARMEL VALLEY ROAD, CARMEL CREEK ROAD,

CARMEL VIEW ROAD and CARMEL GROVE ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
