WHEREAS, his growing experience and expertise led to his appointment in December 1971 as a Deputy City Attorney in the Litigation Division of the Office of the City Attorney, where his duties included the preparation and trial of personal injury lawsuits on behalf of The City of San Diego; and

WHEREAS, Vincent P. Di Figlia's expertise, knowledge of the law and professionalism resulted in the successful resolution of numerous lawsuits involving The City of San Diego; and


