A RESOLUTION AMENDING THE PROGRESS GUIDE AND GENERAL PLAN TO INCORPORATE THEREIN THE TIA JUANA RIVER VALLEY COMMUNITY PLAN, OTAY MESA-NESTOR COMMUNITY PLAN, TECOLOTE CANYON NATURAL PARK MASTER PLAN, UNIVERSITY COMMUNITY PLAN, LINDA VISTA COMMUNITY PLAN, FIRST SAN DIEGO RIVER IMPROVEMENT PROJECT, MIRA MESA COMMUNITY PLAN, NORTH CITY WEST COMMUNITY PLAN (EMPLOYMENT CENTER), NORTH CITY WEST COMMUNITY PLAN (NEIGHBORHOOD 7), THE FAIRBANKS COUNTRY CLUB ANNEXATION, HILLSBOROUGH EAST ANNEXATION, MISSION GORGE NO. 2 ANNEXATION (GEDDES), THE OPEN SPACE ELEMENT AND MAP, THE PHASED DEVELOPMENT AREAS MAP, AND THE DIAMOND ANNIVERSARY COMMEMORATION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the PROGRESS GUIDE AND GENERAL PLAN of The City of San Diego be, and the same is hereby amended by incorporating therein the following:

1. The Tia Juana River Valley Community Plan Amendment of January 18, 1983.
2. The Otay Mesa-Nestor Community Plan Amendment of January 18, 1983 and April 19, 1983.
3. The Tecolote Canyon Natural Park Master Plan adopted May 24, 1983.
4. The University Community Plan Amendment of June 21, 1983.
5. The Linda Vista Community Plan Amendment of July 12, 1983.
6. The First San Diego River Improvement Project Amendment of July 19, 1983.

7. The Mira Mesa Community Plan Amendment of September 13, 1983.
8. The North City West Community Plan (Employment Center) Amendment of September 13, 1983.
9. The North City West Community Plan (Neighborhood 7) Amendment of October 18, 1983.
10. The Fairbanks Country Club Annexation, approved by this Council January 11, 1983, and which became effective on February 1, 1983.
11. The Hillsborough East Annexation, approved by this Council February 14, 1983, and which became effective on March 15, 1983.
12. The Mission Gorge No. 2 Annexation (Geddes), approved by this Council July 11, 1983, and which became effective August 11, 1983.
13. The Open Space Element and General Plan Maps which will bring the open space system into conformance with the proposals of the community plans and reflect the acquisition of open space lands by the City and other public agencies.
14. The map depicting Phased Development Areas and community plan boundaries, reflecting updated community plan area names and boundaries, as well as the new City boundaries.
15. The Diamond Anniversary Commemoration Amendment commemorating the Diamond Anniversary of City Planning in San Diego which is to be reproduced with the General Plan amendment materials.
