A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CONSENTING TO A JOINT PUBLIC HEARING ON THE PROPOSED FIRST AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE DELLS REDEVELOPMENT PROJECT, AUTHORIZING THE ESTABLISHMENT OF A DATE, TIME AND PLACE THEREFOR, AND AUTHORIZING PUBLICATION AND MAILING OF NOTICE OF JOINT PUBLIC HEARING ON THE PROPOSED FIRST AMENDMENT.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has prepared a proposed First Amendment to the Redevelopment Plan for the Dells Redevelopment Project; and

WHEREAS, the California Community Redevelopment Law (Section 33458) authorizes a joint public hearing on the proposed First Amendment to the Redevelopment Plan for the Dells Redevelopment Project with the consent of the Agency and the Council of The City of San Diego; and

WHEREAS, the Agency by resolution has consented to a joint public hearing on the proposed First Amendment to the Redevelopment Plan for said Project and has requested that the Council consent to such joint public hearing and establish the date, time and place therefor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. The Council hereby consents to a joint public hearing on the proposed First Amendment to the Redevelopment Plan for the Dells Redevelopment Project and hereby authorizes the City

Clerk in cooperation with the Executive Director of the Agency (or his designee) to establish a date, time and place for such joint public hearing.

2. The City Clerk shall, in cooperation with the Executive Director of the Agency (or his designee) publish and mail notice of public hearing on the proposed First Amendment to the Redevelopment Plan, in the manner, and with other documents as required and established by law.
