BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 468, San Diego, California, on file in the Office of the City Clerk of San Diego, California on NOV 15 1993, and bearing official document No. W.D. 170941/180591, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 468.


BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$909,214.00 from Water Revenue Fund 41500, Annual Allocation for Water Main Replacement, CIP 73-083, and \$1,354,000.00 from Sewer Revenue Fund 41506, Annual Allocation for Sewer Main Replacement,

CIP 44-001, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


