AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 5, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 75.0117 RELATING TO TAXICAB REGULATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VII, Article 5, Division 1, of the San Diego Municipal Code be and it is hereby amended by amending Section 75.0117 to read as follows:

## SEC. 75.0117 OPERATING REGULATIONS

- Every driver shall offer each passenger a receipt upon payment of the fare. The receipt shall accurately show the date, the starting and ending locations for the trip, the amount of the fare, company name and the name and signature of the driver.
- (b) through (e) no changes to these subsections. Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
