AN ORDINANCE AMENDING CHAPTER III, ARTICLE 2 OF
THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION
32.60, RELATING TO EXCLUSIONS AND EXEMPTIONS OF
SALES TAX.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter III, Article 2 of the San Diego
Municipal Code be and the same is hereby amended by repealing
Section 32.60, as follows:

SEC. 32.60 APPLICATION OF PROVISIONS RELATING
TO EXCLUSIONS AND EXEMPTIONS

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.

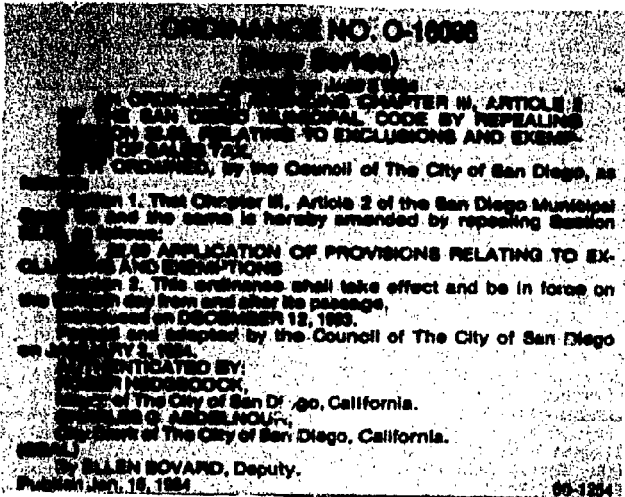
