AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0101.76, RELATING TO SINGLE ROOM OCCUPANCY UNIT

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 1, of the San Diego Municipal Code be, and the same is hereby amended by adding Section 101.0101.76 to read as follows:

SEC. 101.0101.76 SINGLE ROOM OCCUPANCY (SRO) UNIT

A dwelling unit within a hotel providing sleeping and living facilities in which cooking and sanitary facilities may be provided within the unit or may be shared.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
