AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16007-1 AND NO. OO-16007-2, AS AMENDED AND ADOPTED THEREIN, BY AMENDING SECTION 2, SUBSECTION II.1, "TRANSIENT OCCUPANCY TAX FUND" TO INCLUDE A NEW PROGRAM (91511) ENTITLED "KINGDOM DAY PARADE" AND PROVIDE THE SUM OF \$1,000 FOR SAID PROGRAM.

WHEREAS, on December 14, 1983, the Council Committee on Public Services and Safety unanimously approved an allocation of \$1,000 of Transient Occupancy Tax Funds to the National Cultural Foundation; and

WHEREAS, said funds are to be used to help support the Kingdom Day Parade on January 15, 1984 and to promote The City of San Diego; and

WHEREAS, said funds will be provided by a transfer from the line item entitled "Reimburse General Fund - Administration Program" of the Special Promotional Programs and if the sum currently earmarked as a reserve against a Holiday Bowl deficit is not needed, the \$1,000 will be "returned" to the above program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO

OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. 00-16007-1 and No. 00-16007-2, as amended and adopted therein, by adding to Section 2, subsection II.1, "Transient Occupancy Tax Fund (10223)" a new Program (91511) entitled "Kingdom Day Parade."

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$1,000 within the Transient Occupancy Tax Fund 10223 from Program 91557, Reimburse General Fund - Administration to newly established Program 91511, Kingdom Day Parade, to be used solely and exclusively for the purpose of supporting the Kingdom Day Parade and promoting The City of San Diego, pursuant to terms and conditions of the letter agreement between The City of San Diego and the National Cultural Foundation, on file in the office of the City Clerk as Document No. R-259889

Section 3. That the aforesaid Section 2, subsection II.1, be and it is hereby further amended by adding the following language to the narrative as the last paragraph:

Of the \$25,000 which is appropriated to offset a deficit in the Holiday Bowl Game but which may not be needed for that purpose, \$1,000 is hereby authorized for transfer to "Reimburse General Fund - Administration Program."

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
