ORDINANCE NUMBER 0- 161.19 (New Series) Adopted on JAN 17 1984

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.0417.1, RELATING TO REZONING PROPERTY IN 'S' SUFFIX ZONES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code, be, and the same is hereby amended by adding Section 101.0417.1, as follows:

Upon the effective date of the ordinance enacting this section, all property in The City of San Diego to which has been applied the CA-S Zone (Municipal Code, Section 101.0428), C-1S Zone (Municipal Code, Section 101.0430), and CS Zone (Municipal Code, Section 101.0432), shall be zoned CA (Municipal Code, Section 101.0432), shall be zoned CA (Municipal Code, Section 101.0428.1), C-1 (Municipal Code, Section 101.0430.1) and C (Municipal Code, Section 101.0432.1), respectively, and the use and development of such land shall be governed by the provisions of the CA, C-1 and C Zones and all other applicable provisions of the Municipal Code, including Chapter X, Article 1, Division 11.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
