ORDINANCE NUMBER O- 16121 (New Series) Adopted on JAN 17 1984

AN ORDINANCE INCORPORATING APPROXIMATELY 10 ACRES OF PROPERTY LOCATED ON BOTH SIDES OF SAN DIEGO AVENUE, KETTNER BOULEVARD AND CALIFORNIA STREET, BETWEEN WITHERBY AND WASHINGTON STREETS, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1, R-1000 AND CO ZONES, AS DEFINED BY SECTIONS 101.0430.1, 101.0410 AND 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12990, ADOPTED OCTOBER 20, 1930 AND ORDINANCE NO. 3071 (NEW SERIES), ADOPTED SEPTEMBER 25, 1945, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That approximately 10 acres of property located on both sides of San Diego Avenue, Kettner Boulevard and California Street, between Witherby and Washington Streets, in the Uptown Community Plan area, in the City of San Diego, California, within the boundary of the districts designated "C-1," "R-1000" and "CO" on Zone Map Drawing No. B-3599.2, filed in the office of the City Clerk as Document No. 768789, be, and they are hereby incorporated into C-1, R-1000 and CO Zones, as such zones are described and defined by Sections 101.0430.1, 101.0410 and 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12990, adopted October 20, 1930, and Ordinance No. 3071 (New Series), adopted September 25, 1945, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in

force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
