AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,
DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 101.0511, RELATING TO
RESTRICTION ON REAPPLICATION FOR CONDITIONAL USE
PERMIT.

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:


Section 1. That Chapter X, Article 1, Division 5, of the
San Diego Municipal Code be, and the same is hereby amended by
amending Section 101.0511 to read as follows:

SEC. 101.0511 RESTRICTION ON REAPPLICATION FOR
A CONDITIONAL USE PERMIT

Unless a waiver of this section is granted by the City
Council, with the advice of the Planning Director, no
application for a Conditional Use Permit on the same
property or essentially the same property, for the same or
essentially the same use which has been denied by the
Zoning Administrator, the Board of Zoning Appeals, the
Planning Commission or the City Council shall be accepted
within twelve months of such denial.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
