ORDINANCE NUMBER O- 16134 (New Series)

Adopted on JAN 23 1984

AN ORDINANCE INCORPORATING LOTS 3 AND 4, MIDWAY ESTATES UNIT NO. 1, MAP NO. 3937, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODF, AND REPEALING ORDINANCE NO. 7548 (NEW SERIES), ADOPTED AUGUST 15, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:


Section 1. That Lots 3 and 4, Midway Estates Unit No. 1, Map No. 3937, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3601, filed in the office of the City Clerk as Document No. 768783, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7548 (New Series), adopted August 15, 1957, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
