AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING SECTION 3 OF ORDINANCE NO. 0-15647 (NEW SERIES), ADOPTED JANUARY 4, 1982, ESTABLISHING THE GASLAMP QUARTER BUSINESS IMPROVEMENT DISTRICT PURSUANT TO THE PARKING AND BUSINESS IMPROVEMENT AREA LAW OF 1979 AND LEVYING AN ASSESSMENT AND CHARGE THEREIN FOR UPGRADING AND PROMOTING THE AREA.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 3 of Ordinance No. O-15647 (New Series) adopted January 4, 1982, is hereby amended to read as follows:

Section 3. That all businesses operating in the above-described area will be charged a share of the costs of the aforesaid services and programs according to the size of the business and benefit received determined as follows:

## a. CATEGORY OF BENEFIT A

This category consists of non-profit, taxexempt charitable organizations. There shall be
no charge to organizations in this category.
This category includes but is not limited to the
following:

Goodwill Industries of San Diego County
City Rescue Mission

## b. CATEGORY OF BENEFIT B

This category consists of those businesses which benefit from the general enhancement of business activity derived from those services and programs listed in Exhibit A. The increased visibility generated by the BID does not significantly benefit this category of business. There shall be an annual charge of \$50.00 plus \$2.00 per full-time employee to businesses in this category. These businesses include but are not limited to the following: Manufacturers & Manufacturing Representatives Auctioneers Ambulance Companies & Emergency Vehicles Storage Facilities (Automobiles, Boats & Airplanes) Utility Companies Credit Collection Bureaus

Film & Video Production Companies

Laboratories

Accounting/Bookeeping Services

Secretarial Services

## c. CATEGORY OF BENEFIT C

This category consists of those businesses which benefit significantly from the enhancement of business activity derived from those services and programs listed in Exhibit A. The increased visibility generated by the BID significantly improves the business activity and overall

climate of businesses in this category. There shall be an annual charge of \$70.00 plus \$4.00 per full-time employee to businesses in this category. These businesses include but are not limited to the following:

Businesses not specifically identified in Categories

A, B, or C above shall be categorized by the City Treasurer

upon application for a City general business license.

The above-described charge is an annual charge and shall be levied, collected and enforced in the same manner, at the same time, and with the same penalties and interest as in the case of the general business license. For those businesses licensed for other than an annual license period, the City Treasurer shall determine the charge to be levied upon issuance of the City business license. The

total charge collected from any business under the provisions of the ordinance shall not exceed \$250.00 per annum.

The costs of such services and programs to be derived from said charge are shown on Exhibit A incorporated herein.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
