AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16007-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF POLICE DEPARTMENT (110) EIGHT (8) INTERMEDIATE TYPIST POSITIONS FOR THE PURPOSE OF PROVIDING CLERICAL SUPPORT TO COMMUNITY RELATIONS STOREFRONT OPERATIONS.

WHEREAS, Councilmembers Dick Murphy and William Jones sent a memorandum, dated November 1, 1983, to the Mayor and City Council proposing additional personnel for the Police Department to enhance the department's Crime Prevention/Neighborhood Watch Program; and

WHEREAS, the City Council considered said proposal at its regularly scheduled meeting of Tuesday, November 1, 1983, and discussed the matter of adding additional personnel as recommended; and

WHEREAS, the Council voted unanimously, by Resolution No. R-259548, to adopt said proposed recommendation, as amended, to provide eight (8) additional Intermediate Typists and further directed the City Attorney to prepare an amendment to the annual appropriation ordinance to provide for the additional personnel, the costs of which will be absorbed by salary savings in the Police Department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16007-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 110, Police Department, eight (8) Intermediate Typist positions, the cost of which, in the amount of \$76,904, is to be absorbed by the departmental salary savings.

Section 2. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
