AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16007-1 AND NO. OO-16007-2, AS AMENDED AND ADOPTED THEREIN, BY APPROPRIATING THE SUM OF \$2,522,939 FROM GENERAL FUND UNAPPROPRIATED ESTIMATED REVENUE: AMENDING SECTION 2, SUBSECTION I, TO ADD THE SUMS OF \$2,000,000 TO CLAIMS, \$300,000 TO LIBRARY, AND \$222,939 TO BUILDING INSPECTION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. O0-16007-1 and No. OO-16007-2, as amended and adopted therein, by appropriating the sum of \$2,522,939 from General Fund Unappropriated Estimated Revenues and adding said sum to the General Fund for augmentation purposes as set forth in section 2 below.

Section 2. That section 2, subsection I, of said Ordinance No. O-16007 (New Series), as amended, be and the same is hereby further amended by adding the following sums to line items as indicated:

a. Add \$2,000,000 to Non-Departmental Claims Program (60106) for the purpose of defraying anticipated claims.

- b. Add \$300,000 to the Library Department (310) for the purpose of the library automation project.
- c. Add the sum of \$222,939 to the Building Inspection Department (130) for personal expenses attributable to mid-year hiring of additional building inspectors (\$154,517) and for non-personnel expenses due to increased expenses for contractual plan checks (\$68,422).

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
