AN ORDINANCE AMENDING ORDINANCE NO. 0-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16007-1 AND 00-16007-2, AS AMENDED AND ADOPTED THEREIN, BY AMENDING SECTION 2, SUBSECTION II.1, "TRANSIENT OCCUPANCY TAX FUND" (10223) TO CREATE AND INCLUDE A NEW PROGRAM (91689) ENTITLED "FACILITIES IMPROVEMENT PROGRAM;" APPROPRIATING TO SAID FUND (10223) THE SUM OF \$50,000 FROM TRANSIENT OCCUPANCY TAX UNAPPROPRIATED FUND BALANCE FOR ALLOCATION TO SAID "FACILITIES IMPROVEMENT PROGRAM" (91689) FOR TEMPORARY RESTROOM FACILITIES IN THE DOWNTOWN AREA; FINDING AND DECLARING THAT THE EXPENDITURE OF SAID FUNDS IS IN AID OF AND FOR THE PROMOTION OF THE CITY OF SAN DIEGO; DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS AS INDICATED HEREIN.

WHEREAS, the need for restrooms in the downtown area has been discussed at Public Services and Safety Committee on a couple of occasions; and

WHEREAS, it has been proposed that permanent facilities be constructed in the downtown area for use by both visitors and the transient population; and

WHEREAS, utilizing temporary facilities for a period of time will resolve the existing problem and give us needed information with regard to the number and location of the permanent facilities; and

WHEREAS, funds to provide such temporary restroom facilities have been identified in the Transient Occupancy Tax Fund (10223) Unappropriated Fund Balance; and

WHEREAS, it is now required to amend the Annual
Appropriation Ordinance to establish a "Facilities Improvement
Program" for the purpose of authorizing and reflecting such
additional promotional service; and

WHEREAS, the Transient Occupancy Tax Fund (10223) monies to be used for this purpose are for the promotion of The City of San Diego and the provision of such facilities in the downtown San Diego area is deemed to be promotional in nature; and

WHEREAS, funds will be included in the FY 1985 proposed budget to continue this program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. OO-16007-1 and No. OO-16007-2, as amended and adopted therein, by creating and adding to Section 2, subsection II.1, "Transient Occupancy Tax Fund" (10223) a new program entitled "Facilities Improvement Program" (91689).

Section 2. That there is hereby appropriated and added to said Fund (10223) the sum of \$50,000 in Transient Occupancy Tax Fund (10223) Unappropriated Fund balance for allocation to said "Facilities Improvement Program" (91689) to serve solely and exclusively for the purpose of providing temporary restroom facilities in the downtown San Diego area, thereby aiding the promotion of said City.

Section 3. That this Council finds and declares that the expenditure of Transient Occupancy Tax Funds from Fund 10223 for the facilities described in section 2 above are in aid of and for the promotion of The City of San Diego, complying thereby with the purpose and intent of section 35.0101, et seq. of the San Diego Municipal Code.

Section 4. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer said funds as specified in section 2 above.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
