AN ORDINANCE AMENDING ORDINANCE NO. 0-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16007-1 AND 00-16007-2, AS AMENDED AND APOSTED THEREIN, BY AMENDING SECTION 2, SUBSECTION 11.4, "REVENUE SHARING FUNDS" (18011-18012) BY ADDING A NEW FUND (18013), ENTITLEMENT PERIOD 15, OCTOBER 83 -SEPTEMBER 84, AND ADDING THEREUNDER A NEW PROGRAM ENTITLED "UDAG GRANT MATCH-HOTEL CONSTRUCTION, SOUTHEAST SAN DIEGO" AND ESTABLISH SAME UNDER FUND 18013, ENTITLEMENT PERIOD 15; APPROPRIATING AND ADDING TO SAID FUND (18013) AND PROGRAM THE SUM OF \$310,000 IN REVENUE SHARING FUNDS; DIRECTING THE AUDITOR AND COMPTROLLER TO ALLOCATE FUNDS AS INDICATED HEREIN.

WHEREAS, on January 9, 1983, the Rules Committee directed the City Manager to identify funds to match a \$1,240,000 UDAG grant to be used for new construction of a hotel and amenities on the site of an existing motel in Southeast San Diego; and

WHEREAS, the such funds have been identified in Revenue
Sharing Funds to be available for appropriation, allocation and
expenditure in Entitlement Period 15, October 1983 - September
1984; and

WHEREAS, it is now desired and required to amend the annual appropriation ordinance to reflect said source of revenue sharing funds for the purpose of providing said matching funds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance Mo. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. OO-16007-1 and No. OO-16007-2, as amended and adopted therein, by creating and adding to section 2, subsection II.4, "Revenue Sharing Funds" (18011-18012) a new Fund 18013, Entitlement Period 15, October 83 - September 84.

Section 2. That there is hereby appropriated and added to said Fund (18013) the sum of \$310,000 in Revenue Sharing funds under a newly authorized and created program, entitled "UDAG Grant Match-Hotel Construction, Southeast San Diego" to serve solely and exclusively as matching runds for a Southeast Economic Development Corporation UDAG grant for new construction of a hotel and amenities on the site of an existing motel in Southeast San Diego, pursuant to the terms and conditions of an agreement to be executed by and between The City of San Diego and the Southeast Economic Development Corporation.

Section 3. That the Auditor and Comptroller be and he is hereby authorized and directed to allocate said funds as specified in section 2 above upon approval by the City Council after the conduct of a public hearing as required for allocation and expenditure of revenue sharing funds.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.


