AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 4 OF THE SAN DIEGO MUNICIPAL CODE BY RENUMBERING SECTION 64.32.4 TO SECTION 64.0411, RELATING TO SEWER RATES ADJUSTMENTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 4 of the San Diego Municipal Code be and the same is hereby amended by renumbering Section 64.32.4 to Section 64.0411 to read as follows:

SEC. 64.0411 SEWER RATES--ADJUSTMENTS

The sewer rates established in this Article shall be adjusted annually by the City Manager to be compensated proportionately for any increase in the cost of energy purchased by the City. Annual adjustments shall be effective on the first day of January each year. Notice of such increase in sewer rates shall be given by the City Manager to the City Council by report and to the public by publication once in the City Official Newspaper on or before the thirtieth (30th) day prior to the effective date of such increase.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Annual adjustments shall be effective on the first day of January sech year. Notice of such increase in sewer rates shall be given by the City Manager to the City Council by report and to the public by publication once in the City Official Newspaper on or before the thirtieth (30th) day prior to the effective date of such increase.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
