AN ORDINANCE AUTHORIZING AN OPERATING AGREEMENT WITH VILLAVIEW COMMUNITY HOSPITAL AND AN INDENTURE, A CONTRACT OF INSURANCE AND A REGULATORY AGREEMENT IN CONNECTION WITH THE ISSUANCE OF CITY OF SAN DIEGO INSURED HOSPITAL REVENUE BONDS (VILLAVIEW COMMUNITY HOSPITAL) IN A PRINCIPAL AMOUNT NOT TO EXCEED \$7,250,000.

WHEREAS, the City Council of The City of San Diego (the "City"), acting under and pursuant to the powers reserved to the City under Sections 3, 5 and 7 of Article XI of the Constitution of the State of California and Section 2 of the Charter, and The City of San Diego Health Facility Revenue Bond Law (herein called the "Law"), constituting Article 7 of Chapter IV of the Municipal Code of the City has provided for the issuance of its hospital revenue bonds to finance and refinance certain equipment and improvements at VillaView Community Hospital (the "Corporation"); and

WHEREAS, the City Council finds that the public interest and necessity require the City to enter into an operating agreement with the Corporation, an indenture between the City and a corporate trustee setting forth the terms of said bonds and providing for the payment and security thereof, and a contract of insurance and regulatory agreement among the City, the Corporation and the Office of Statewide Health Planning and Development of the State of California (the "Office") providing for the insurance of the Bonds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager and other proper officers of the City are authorized to prepare and to enter into for and in the name and on behalf of the City in accordance with The City of San Diego Health Facility Revenue Bond Law, an operating agreement in substantially the same form as the form of operating agreement on file in the office of the City Clerk as with the Corporation providing for a loan to the Corporation to be funded by the issuance of hospital revenue bonds of the City in a principal amount not to exceed \$7,250,000 and for a term not to exceed forty years, an indenture in substantially the same form as the form of indenture on file in the office of the City Clerk as Document No. RR-260238-1 between the City and a corporate trustee setting forth the terms of said bonds and providing for the payment and security thereof, a contract of insurance and regulatory agreement in substantially the same form as the form of agreements on file in the office of the City Clerk as RR-260238-3 RR-260238-4 among the City, the Document Nos. Corporation and the Office providing for the insurance of said bonds, and all necessary and appropriate documents in connection therewith; provided, however, that the final form of said agreements and of said indenture shall be submitted to the Council for approval by resolution prior to their respective execution by the City.

Section 2. The City Clerk is hereby authorized and directed to cause a digest or a copy of this ordinance to be published at least once in "The San Diego Daily Transcript" within fifteen days after its final passage pursuant to Section 18 of the Charter.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
