AN ORDINANCE PURSUANT TO SECTION 99 OF THE CITY CHARTER AUTHORIZING A LEASE AGREEMENT (HEAVY VEHICLE MAINTENANCE FACILITY) WITH RAUSCHER PIERCE REFSNES LEASING, INC., A TRUST AGREEMENT WITH BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION AND A FEE SCHEDULE FOR TRUST SERVICES RELATED TO THE ISSUANCE OF CERTIFICATES OF PARTICIPATION IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$3,625,000 FOR A TERM NOT EXCEEDING 30 YEARS.

WHEREAS, it is necessary for The City of San Diego ("City") to acquire by lease a heavy vehicle maintenance facility (the "Project"); and

WHEREAS, Rauscher Pierce Refsnes Leasing, Inc. ("Lessor") is willing to assist the City by financing the construction of the Project, together with all structures, improvements and all facilities related thereto or provided therefor, and the outfitting thereof; and

WHEREAS, as a financing mechanism, Certificates of

Participation will be executed and delivered evidencing a

proportionate interest of the holder thereof in lease payments

(the "Lease Payments") to be made by the City to Lessor; and

WHEREAS, Bank of America National Trust and Savings
Association ("Trustee") will be designated the Trustee to
receive the Lease Payments and to pay the principal and interest
to the holders of the Certificates of Participation; and

WHEREAS, pursuant to Section 99 of the Charter of The City of San Diego, a noticed hearing was held on April 23, 1984, regarding the acquisition and leasing of the Project and the

agreements to be entered into to carry out the purposes of said Project as referred to in the recitals hereof; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The proposed form of Lease Agreement, dated as of March 1, 1984, by and between the City and Lessor, which is on file in the office of the City Clerk as Document No.

00-16200, is hereby approved. Lease Payments payable by the City in any calendar year over the term of the Lease Agreement shall exceed the amount set forth in Exhibit A to the Lease Agreement, provided, however, the Lease Payments set forth therein may be reduced when the interest component of the Lease Payments is determined. The City Manager and the City Clerk are, subject to Section 5 hereof, authorized and directed to execute said Lease Agreement on behalf of the City and to make any modifications in the Lease Payments is determined. When the interest component of the Lease Payments is determined.

Section 2. The proposed form of Trust Agreement, dated as of March 1, 1984, by and among Trustee, Lessor and City, which is on file in the office of the City Clerk as Document No.

00-16200, is hereby approved. The City Manager and the City Clerk are authorized and directed to execute said Trust Agreement on behalf of the City, and to insert the appropriate interest rates and principal maturity schedule in Section 3.04 thereof after the interest component of the Lease Payments and such principal maturity schedule are determined.

Section 3. Trustee, as compensation for acting as Trustee pursuant to the aforesaid Trust Agreement, is hereby authorized

to pay to itself out of the proceeds of the delivery of said Certificates of Participation such amounts to which it is entitled pursuant to its letter to the City dated

MAR 30, 1984, a copy of which is on file in the office of the City Clerk as Document No. 00-16199-3

Section 4. The Lease Agreement and Trust Agreement are subject to minor changes not inconsistent with the essential terms thereof and which are approved by the City Manager and the City Attorney. The City Manager's approval of such changes shall be conclusively established by execution of the Lease Agreement and Trust Agreement.

Section 5. The Lease Agreement and Trust Agreement shall not be executed by the City Manager and City Clerk until a Purchase Agreement and Official Statement for the Certificates of Participation are approved by the City Council.

Section 6. The City reserves the right, at its option, to make future modifications to this ordinance if deemed in the City's interest, if a determination is made that the City would benefit by using a financing plan which would require substantial changes in the Lease Agreement and Trust Agreement described above.

Section 7. The City Clerk is authorized and directed to cause a digest or copy of this ordinance to be published at least once in "The San Diego Daily Transcript" within fifteen (15) days after the adoption of this ordinance pursuant to Section 18 of the City Charter.

Section 8. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
