AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN CITY-OWNED LAND IN THE MISSION GORGE AREA, BOUNDED BY THE PROPOSED HIGHWAY 52, MISSION GORGE ROAD AND CLAIREMONT MESA BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That a portion of Lot 70 of the Rancho Mission of San Diego, together with Lot 6 in Block "H" of the Subdivison of Fanita Rancho (Revised), Map No. 688, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council specifically reserves the right to establish easements for utility purposes in, under and across the property hereby dedicated so long as such easements and the facilities to be located therein do not significantly interfere with the park and recreational use of the subject property.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

That a portion of Lot 70 of the Rancho Mission of San Diego, together with Lot 6 in Block "H" of the Subdivision of certain parcels (Revised), Map No. 922, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.
Section 2. That the City Council specifically reserves the right to establish easements for utility purposes in, under and across the property hereby dedicated so long as such easements and the facilities to be located therein do not significantly interfere with the park and recreational use of the subject property.
Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.
Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
