AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. O-15661 (NEW SERIES), ADOPTED FEBRUARY 1, 1982, INCORPORATING THE SOUTHWEST 1/4 OF LOT 10, HORTON'S PURCHASE, MAP NO. 283, EXCEPTING FAIRMONT PARK, MAP 2874, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. O-15661 (New Series), adopted February 1, 1982; and

WHEREAS, Section 1 of Ordinance No. 0-15661 (New Series) provided that the M-1B Zone would attach if a final map or maps were recorded on or before March 3, 1984; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. O-15661 (New Series), adopted February 1, 1982, is hereby amended to read as follows:

Section 1. That in the event that the Southwest 1/4 of Lot 10, Horton's Purchase, Map No. 283, excepting Fairmont Park, Map 2874, in the City of San Diego, California, within the boundary of the district designated "M-1B" on that certain Zone Map Drawing No. B-3456.1, is subdivided and a final subdivision map or maps thereof duly submitted

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
