AN ORDINANCE AMENDING ORDINANCE NO. 0-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16007-1, AND NO. OO-16007-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING AN AMOUNT OF \$25,000 FROM THE GENERAL FUND 100, DEPARTMENT 110, ORGANIZATION 222, OBJECT ACCOUNT 4222 TO C.I.P. PROJECT NO. 36-003.5, "NORTHERN DIVISION POLICE STATION -FENCING" TO PROVIDE FUNDS FOR PROJECT COMPLETION; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER SAID AMOUNT.

WHEREAS, the Council included in the annual appropriation ordinance, a Capital Improvement identified as C.I.P. No. 36-003.5, "Northern Division Police Station - Fencing," intended to provide funding for perimeter fencing and security lighting at the Northern Police Station; and

WHEREAS, there was at that time, no funding included for paving; and

WHEREAS, it is now necessary and desirable to transfer additional funds into C.I.P. No. 36-003.5 to complete the original project and provide for pavement of additional parking area; and

WHEREAS, funds have been identified and are available in the Fiscal Year 1984 Police Department budget due to contractual services savings; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Documents No. OO-16007-1 and No. OO-16007-2, as amended and adopted therein, by transferring an amount of \$25,000 from the General Fund 100, Department 110, Organization 222, Object Account 4222, to C.I.P. Project No. 36-003.5, entitled "Northern Division Police Station - Fencing" to provide funding to complete the original project and provide for pavement of additional parking area.

Section 2. That the City Auditor and Comptroller be and he is hereby fully authorized and directed to transfer the amount as set forth in Secton 1 above.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
