ORDINANCE NUMBER O- 16216 (New Series)

AN ORDINANCE AUTHORIZING A LOAN AGREEMENT WITH UNITOG RENTAL SERVICES, INC. AND AN INDENTURE OF TRUST WITH A TRUSTEE IN CONNECTION WITH THE ISSUANCE OF CITY OF SAN DIEGO INDUSTRIAL DEVELOPMENT REVENUE BONDS (UNITOG RENTAL SERVICES, INC.), IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$2,500,000.

WHEREAS, the City Council of The City of San Diego (the "City") has, by Ordinance No. 0-15586 (New Series), adopted by the Council on September 14, 1981, enacted an Act of The City of San Diego entitled the Economic Development Revenue Bond Law (the "Law"), amending Article 7 of Chapter IX of the Municipal Code of the City by adding Divisions 1, 2, 3 and 4, authorizing and establishing a procedure for the sale and issuance of revenue bonds or other evidences of indebtedness by the City for the purpose of providing financing to participating parties for economic development purposes; and

WHEREAS, the City Council of the City has, by Resolution No. R-259849, as supplemented by Resolution No. R-260194, adopted by the Council on December 13, 1983 and February 27, 1984, respectively, given preliminary approval for the issuance of one or more series of such bonds or other evidences of indebtedness to fund such a loan to Unitog Rental Services, Inc. (the "Company") to finance the acquisition and construction of certain facilities for use by the Company (the "Project"), and

authorized proper officers of the City to proceed to prepare or cause to be prepared the documentation for such purpose; and

WHEREAS, the Company has requested the City to provide financing for the Project through the sale of such bonds to finance the Project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager and other proper officers of the City are authorized to prepare and to enter into, for and in the name and on behalf of the City, in accordance with the Law, from time-to-time as needed to finance the Project, a Loan Agreement with Unitog Rental Services, Inc. providing for a loan to it to be funded by the issuance of one series of economic development revenue bonds of the City in a principal amount not to exceed \$2,500,000 and for terms not to exceed forty years, and an Indenture of Trust between the City and The Merchants Bank, as trustee, setting forth the terms of said bonds and providing for the payment and security thereof, and all necessary and appropriate documents in connection therewith. Forms of the proposed Loan Agreement and the Indenture are on file in the office of the City Clerk as Document Nos. RR- 260692-1 and RR- 260692-2

Section 2. The City Clerk is hereby authorized and directed to cause a digest or a copy of this ordinance to be published at least once in "The San Diego Daily Transcript"

within fifteen (15) days after the adoption of this ordinance pursuant to Section 18 of the City Charter.

Section 3. This ordinance shall take effect on the thirtieth day from and after its passage.

WHEREAS, the City Council of The City of San Diego (the "City") has, by Ordinance No. O-15688 (New Series), adopted by the Council on September 14, 1981, enacted an Act of The City of San Diego entitled the Economic Development Revenue Bond Law (the "Law"), amending Article 7 of Chapter IX of the Municipal Code of the City by adding Divisions 1, 2, 3 and 4, authorizing and establishing a procedure for the sale and issuance of revenue bonds or other evidences of indebtedness by the City for the purpose of providing financing to participating parties for economic development purposes; and

WHEREAS, the City Council of the City has, by Resolution No. R-20094, as supplemented by Resolution No. R-200194, adopted by the Council on December 13, 1983 and February 27, 1984, respectively, given preliminary approval for the issuance of one or more series of such bonds or other evidences of indebtedness to fund such a loan to Unitog Rental Services, Inc. (the "Company") to finance the acquisition and construction of certain facilities for use by the Company (the "Project"), and authorized proper officers of the City to proceed to prepare or cause to be prepared the documentation for such purpose; and

WHEREAS, the Company has requested the City to provide financing for the Project through the sale of such bonds to finance the Project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The City Manager and other proper officers of the City are authorized to prepare and to enter into, for and in the name and on behalf of the City, in accordance with the Law, from time-to-time as needed to finance the Project, a Loan Agreement with Unitog Rental Services, Inc. providing for a loan to it to be funded by the issuance of one series of economic development revenue bonds of the City in a principal amount not to exceed \$2,000,000 and for terms not to exceed forty years, and an Indenture of Trust between the City and The Merchants Bank, as trustee, setting forth the terms of said bonds and providing for the payment and security thereof, and all necessary and appropriate documents in connection therewith. Forms of the proposed Loan Agreement and the Indenture are on file in the office of the City Clerk as Document Nos. RR-20092-1 and RR-20092-2.

Section 2. The City Clerk is hereby authorized and directed to cause a digest or a copy of this ordinance to be published at least once in "The San Diego Daily Transcript" within fifteen (15) days after the adoption of this ordinance pursuant to Section 18 of the City Charter.
