Section 1. That Ordinance No. 0-15863 (New Series) adopted on November 22, 1982, is hereby repealed.

Section 2. That it is the express intent of this Council that anyone who would otherwise be eligible for State tax credits were it not for the existence of the MSU ordinance, be treated as if the MSU ordinance had never been enacted.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
