AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0407.1, RELATING TO RESIDENTIAL ZONE DESIGNATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 4, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0407.1 to read as follows:

SEC. 101.0407.1 REDESIGNATING R-1 ZONES

From and after the effective date of this ordinance, those areas heretofore incorporated into various R-1 zones designated R-1-5, R-1-6, R-1-8, R-1-10, R-1-15, R-1-20 and R-1-40 zones shall be known as the R1-5000, R1-6000, R1-8000, R1-10000, R1-15000, R1-20000 and R1-40000 zones, respectively, and all property development regulations and all provisions set forth in this article for the R1-5000, R1-6000, R1-8000, R1-10000, R1-15000, R1-20000 and R1-40000 zones shall be applicable to those areas previously designated R-1-5, R-1-6, R-1-8, R-1-10, R-1-15, R-1-20 and R-1-40, respectively.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

Section 1. That Chapter X, Article 1, Division 4, of the Sango Municipal Code be, and the same is hereby amended by inding Section 101.0407.1 to read as follows:

SEC. 101.0407.1 REDESIGNATING R-1 ZONES
From and after the effective date of this ordinance, those areas herelofore incorporated into various R-1 zones designated R-1-5, R-1-6, R-1-6, R-1-10, R-1-15, R-1-15, R-1-10, R-1-15, R-1-15, R-1-10, R-1-15, R-1 R1-8000, R1-8000, R1-10000, R1-15000, R1-20000 and R1-40000 zones, respectively, and all property development regulations and all provisions set forth in this article for the R1-8000, R1-6000, R1-8000, R1-10000, R1-15000, R1-20000 and R1-40000 zones shall be applicable to those areas previously designated R1-15, R-1-8, R-1-10, R-1-15, R-1-20 and R-1-40, respectively.

Section 2, This ordinance shall take effect and be in force on the thriteth day from and after its passage.
