AN ORDINANCE AMENDING ORDINANCE NO. 0-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16007-1 AND NO. 00-16007-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING CIP 53-040 entitled, "RANCHO MISSION ROAD BRIDGE OVER SAN DIEGO RIVER," TO THE 1983-84 CAPITAL IMPROVEMENTS PROGRAM, AND AUTHORIZING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$160,500 WITHIN THE SPECIAL GAS TAX STREET IMPROVEMENT FUND (30219) TO REDUCE THE APPROPRIATION FOR THE STREET RESURFACING PROGRAM (93410) BY \$160,500, AND INCREASE THE APPROPRIATION FOR THE CAPITAL IMPROVEMENTS PROGRAM BY \$160,500 FOR CIP 53-040.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16007 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. 00-16007-1 and No. 00-16007-2, as amended and adopted therein, by adding CIP 53-040 entitled, "Rancho Mission Road Bridge over San Diego River" to the 1983-84 Capital Improvements Program.

Section 2. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$160,500 within the Special Gas Tax Street Improvement Fund (30219) to reduce the appropriation for the Street Resurfacing Program (93410) by \$160,500, and increase the appropriation for the Capital

Improvements Program by \$160,500 for CIP 53-040.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
