AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 4, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 44.0116, RELATING TO ILLEGAL DUMPING AND LITTERING.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 4, Division 1 of the San Diego Municipal Code be, and the same is hereby amended by amending Section 44.0116 to read as follows:

SEC. 44.0116 DEFINITIONS

First paragraph, A., B., C., D., E., F., G., H. and I. - NO CHANGE.

J. Waste matter means rubbish, solid waste and any liquid wastes, including but not necessarily limited to, oil, other petroleum products, paint, chemicals and hazardous wastes.

K. - NO CHANGE.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
