ORDINANCE NUMBER O- 16250 (NEW SERIES)

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 26.07 RELATING TO THE CREATION OF A PUBLIC ARTS ADVISORY BOARD.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter II, Article 6 of the San Diego Municipal Code be and it is hereby amended by adding Section 26.07 to read as follows:

SECTION 26.07 PUBLIC ARTS ADVISORY BOARD

A. PURPOSE AND INTENT

It is the purpose and intent of the City Council to establish a Public Arts Advisory Board to serve in an advisory capacity to the Mayor, City Council, and City Manager on projects and programs designed to promote the arts in public places throughout the neighborhoods of the City of San Diego, and to encourage the private sector to include the arts in private developments.

B. PUBLIC ARTS ADVISORY BOARD ESTABLISHED

There is hereby established a Public Arts Advisory Board consisting of eleven (11) members who shall serve without compensation. At least six (6) members shall be persons whose professional background or experience is in the field of landscape

architecture, art administration, sculpture, painting, dance, theater, music, literature, architecture, development or education.

The members shall serve two (2) year terms and each member shall serve until a successor is duly appointed and confirmed. The members shall be appointed by the Mayor and confirmed by the Council. The members shall be appointed in such manner so that the terms of not more than six (6) members shall expire in any year. The expiration date of all terms shall be July 1. The Board shall select from among its members a Chairperson. The Board shall meet not less than once every three (3) months and present quarterly reports to the Public Facilities and Recreation Committee and report to the Mayor and Council on an annual basis.

The Board shall adopt rules consistent with laws for the government of its business and procedures.

C. DUTIES AND FUNCTIONS

The Public Arts Advisory Board shall:

1. Advise upon the acquisition and placement of works of art on any property of the City of San Diego, except for any museum, art gallery or City-owned performance facility. No work of art shall be installed, or existing work of art removed from public areas of City property, without a review by the Public Arts Advisory Board. The Board shall not involve itself in the process of granting public funds.

2. Develop and recommend to the Mayor, City Council and City Manager:

a. Programs to promote public performances and the public exhibition of the visual arts.

b. Legislation to provide incentives to the private sector for the inclusion of the arts in private developments.

c. Programs to develop federal, state and municipal funding to accomplish the purposes stated in Section A.

D. DEFINITIONS

1. "Public exhibition of the visual arts" shall mean paintings, lithographs, reproductions, photographs, murals, handcrafted arts, stained glass, statues, sculptures, and other forms of media arts, which are presented free to the public.

2. "Public performances" shall mean individual and group presentations of music, dance, theatre, and other forms of art generally recognized which are presented free to the public.

3. "Public places" shall mean land and buildings owned by the City, exclusive of City-owned performance facilities, e.g., Civic Theatre.

4. "Works of art" shall mean paintings, reproductions, photographs, murals, handcrafted arts, stained glass, statues, or other sculptures, monuments, fountains, arches and, other structures of a permanent or temporary nature intended for ornament

or commemoration.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
